
# **HOW TO SUBSCRIBE**

### SUBSCRIPTION OF UNITS THROUGH THE EXERCISE OF UNIT RIGHTS

#### 1. You are allotted Unit Rights

For each share in Chosa Oncology AB (publ) that you hold on the record date of 10 June 2025, you will be allotted one (1) unit right.




#### 2. How to Exercise Your Unit Rights

For eight (8) Unit Rights in Chosa Oncology AB (publ), you are entitled to subscribe for one (1) Unit at a price of SEK 1.86 per Unit (SEK 0.62 per share).



#### Unit

Each Unit consists of three (3) shares and three (3) warrants of series TO2.



#### DIRECTLY REGISTERED SHAREHOLDERS

Shareholders or representatives of shareholders who, on the record date of 10 June 2025, are registered with Euroclear will receive a pre-printed issue statement with a payment slip attached. Information will also be available on Nordic Issuing's website (<a href="www.nordic-issuing.se">www.nordic-issuing.se</a>) and the Company's website (<a href="www.nordic-issuing.se">www.nordic-issuing.se</a>). Individuals listed in the separate register connected to the share register for pledgees and similar will not receive this information but will be notified separately. No VP notice showing the registration of unit rights on shareholders' VP accounts will be sent out.

#### Subscription with Preferential Rights

Subscription with preferential rights must be made through simultaneous cash payment no later than 26 June 2025. Subscription via payment can be completed either with the pre-printed payment slip attached to the issue statement, or via Nordic Issuing's platform as described in the following two options:

### Issue Statement (Pre-Printed Payment Slip from Euroclear)

If all unit rights received on the record date are to be exercised for subscription, the pre-printed payment slip must be used as the basis for subscription through cash payment.

## 2. Subscription via Nordic Issuing with Support of Unit Rights

If a different number of unit rights than what appears on the pre-printed issue statement is exercised for subscription — for example, if unit rights have been acquired or sold — the subscription must be made through Nordic Issuing's platform at https://minasidor. nordic-issuing.se/ and used as the basis for subscription through cash payment. The shareholder must log in to the platform and specify the number of unit rights to be exercised, the number of units to subscribe for, and the amount to be paid. The application is binding.

#### NOMINEE-REGISTERED SHAREHOLDERS

Shareholders whose holdings in the Company are nominee-registered with a bank or other nominee will not receive an issue statement. Subscription and payment must instead be made in accordance with the instructions from the respective bank or nominee. Please note that when exercising unit rights via a bank or nominee, this should be done early in the subscription period since banks/nominees may set their own deadlines for the last subscription date.

#### SUBSCRIPTION WITHOUT PREFERENTIAL RIGHTS

Subscription for units without preferential rights shall be made during the same period as for subscription with preferential rights, i.e., from 12 June 2025 to 26 June 2025.

Applications to subscribe for units without preferential rights must be made via Nordic Issuing's platform <a href="https://minasidor.nordic-issuing.se/">https://minasidor.nordic-issuing.se/</a>.

For nominee-registered shareholders, applications for subscription without preferential rights must be submitted to the respective nominee and in accordance with their instructions, or, if holdings are registered with multiple nominees, to each of them separately. To be eligible for subsidiary preferential rights, the subscription must be made through the nominee, as otherwise it will not be possible to identify the subscriber as having subscribed for units both with and without unit rights.

Incomplete or incorrectly filled-in subscription forms may be disregarded. Only one application for "Subscription without Unit Rights" is allowed. Subscription must be made no later than 26 June 2025. The application is binding.
